STATEMENT of REASON



**THE KENT COUNTY COUNCIL (VARIOUS ROADS, BOROUGH OF
SWALE)
(WAITING RESTRICTIONS AND STREET PARKING PLACES)
(AMENDMENT NO.50) ORDER 2023
Road Traffic Regulation Act 1984**

To facilitate the safe passage of vehicles, it is proposed to install double yellow lines on the northwest and western side of Redgrove Avenue, Sittingbourne, between the junctions of Church Street and Jubilee Street.

For the same reason, it is also proposed to extend these double yellow lines into the junctions of Bowater Close, Lywood Drive, Haddon Close and Jubilee Street.

For the following purposes:

- **To avoid danger to persons or other traffic using the road or any other road or to prevent the likelihood of any such danger arising;**
- **To facilitate the passage on the road or any other road of any class of traffic (including pedestrians).**

(AMENDMENT No.50) ORDER 2023**

The Kent County Council, acting as the local traffic authority and in exercise of its powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, ('the Act') and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, propose to make the following Order:-

A - This Order may be cited as "The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) Amendment No.50 Order 2023" ('this Order') and shall come into force on the xx day of xxxxx 2023.

B - The "Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2019" ('the 2019 Order') shall have effect as though -

In the Schedules to the 2019 Order

FIRST SCHEDULE

Roads in Sittingbourne and Milton

Bowater Close

The following shall be inserted in the First Schedule (*No Waiting At Any Time*) in the correct alphabetical sequence:

BOWATER CLOSE On both sides, from the north-western kerblines of Redgrove Avenue for a distance of 7.5 metres in a north-westerly direction.

Haddon Close

The following shall be inserted in the First Schedule (*No Waiting At Any Time*) in the correct alphabetical sequence:

HADDON CLOSE On both sides, from the north-western kerblines of Redgrove Avenue for a distance of 7.5 metres in a westerly direction.

Jubilee Street

The following shall be inserted in the First Schedule (*No Waiting At Any Time*) in the correct alphabetical sequence:

- JUBILEE STREET** (1) On the north side
- (a) from a point in line with the western kerbline of Redgrove Avenue for a distance of 12 metres in a westerly direction;
 - (b) from a point in line with the south-eastern kerbline of Charlotte Street to a point 5 metres east of the eastern boundary line of 119 Charlotte Street.
- (2) On the south side, from a point in line with the western kerbline of Redgrove Avenue to a point in line with the eastern boundary line of 119 Charlotte Street.

Lywood Drive

The following shall be inserted in the First Schedule (*No Waiting At Any Time*) in the correct alphabetical sequence:

- LYWOOD DRIVE** On both sides, from the north-western kerbline of Redgrove Avenue for a distance of 11 metres in a north-westerly direction.

Redgrove Avenue

The following shall be inserted in the First Schedule (*No Waiting At Any Time*) in the correct alphabetical sequence:

- REDGROVE AVENUE** On the north-western and western side
- (a) from a point in line with the back of the south-western footway of Church Street to a point in line with the north-eastern kerbline of Bowater Close;
 - (b) from a point in line with the south-western kerbline of Bowater Close to a point in line with the north-eastern kerbline of Lywood Drive;
 - (c) from a point in line with the south-western kerbline of Lywood Drive to a point in line with the north-eastern kerbline of Haddon Close;
 - (d) from a point in line with the south-western kerbline of Haddon Close to a point in line with the northern kerbline of Jubilee Street.

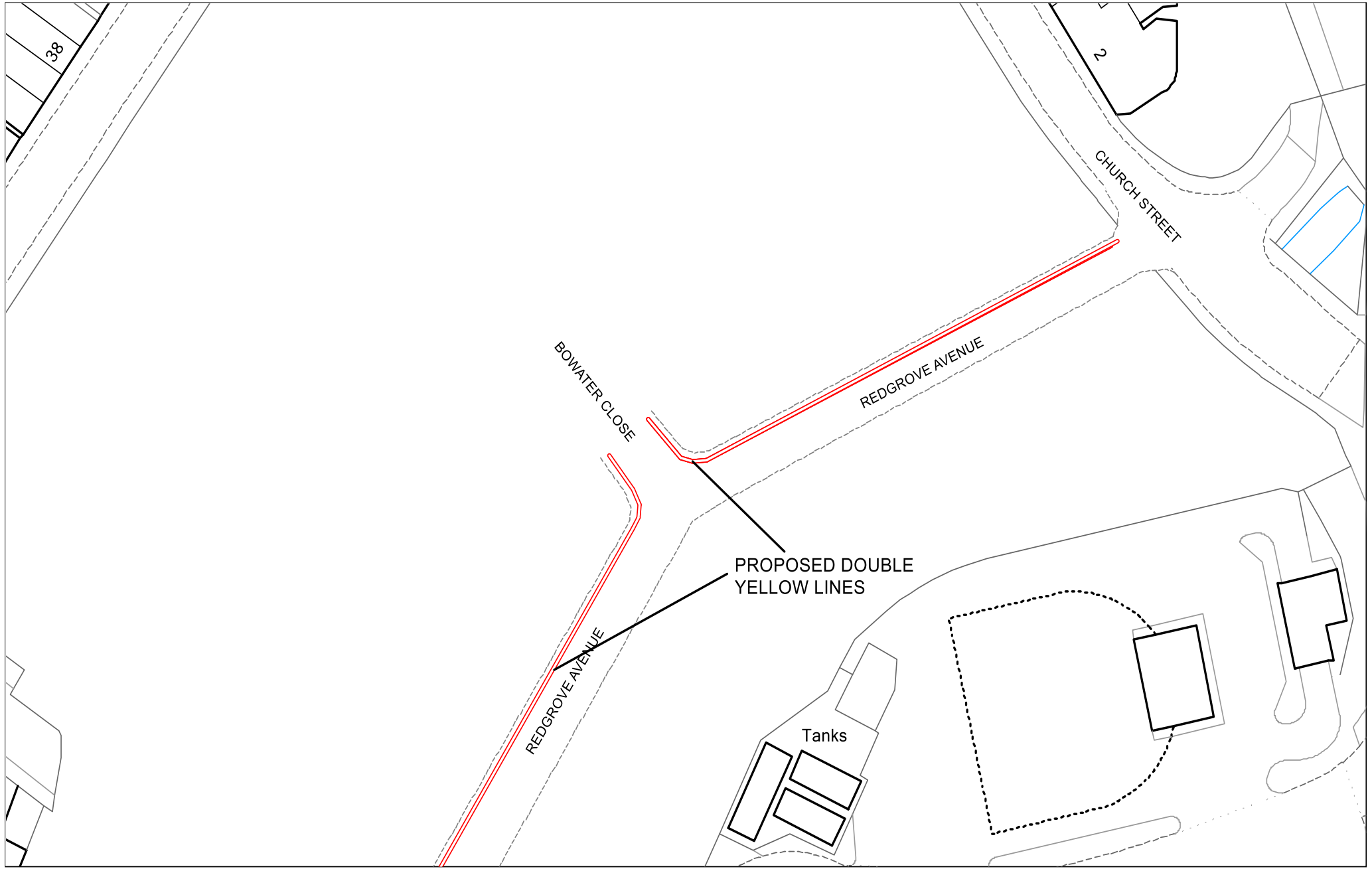

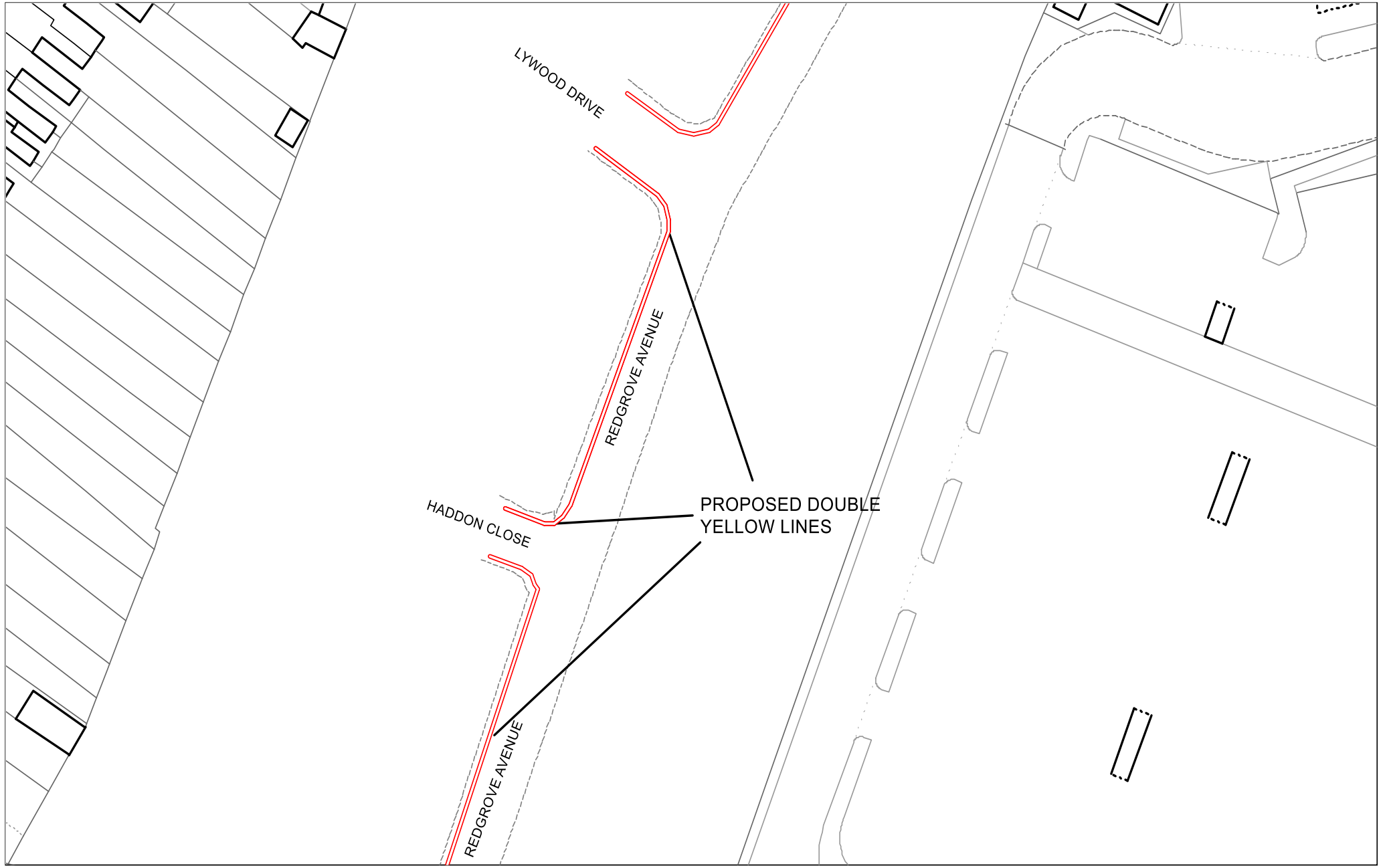
