STATEMENT of REASON



THE KENT COUNTY COUNCIL (VARIOUS ROADS, BOROUGH OF SWALE) (WAITING RESTRICTIONS AND STREET PARKING PLACES) (AMENDMENT NO.47) ORDER 2023 Road Traffic Regulation Act 1984

To accommodate the new junction of Seddingbourne Way it is proposed to adjust the existing double yellow lines on the west side of Crown Quay Lane, Sittingbourne.

To prevent all day parking by commuter vehicles, it is proposed to install single yellow lines with restrictions between 10am and 11am Monday to Friday in Cole Close, Tylden Gardens, Cambria Crescent, Parrett Avenue and Seddingbourne Way, between Parrett Avenue and Tylden Gardens.

These proposals have been requested by the developer of the estate, and were originally included in Traffic Regulation Order Swale Amendment 3 2019 but are being re-advertised in our latest Traffic Regulation Order as they were not installed on site.

For the following purposes:

- To avoid danger to persons or other traffic using the road or any other road or to prevent the likelihood of any such danger arising;
- To facilitate the passage on the road or any other road of any class of traffic (including pedestrians).

THE KENT COUNTY COUNCIL (VARIOUS ROADS, BOROUGH OF SWALE) (WAITING RESTRICTIONS AND STREET PARKING PLACES) (AMENDMENT No.47) ORDER 2023

The Kent County Council, acting as the local traffic authority and in exercise of its powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, ('the Act') and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- A This Order may be cited as "The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) Amendment No.47 Order 2023" ('this Order') and shall come into force on the 16th day of February 2024.
- B The "Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2019" ('the 2019 Order') shall have effect as though -

FIRST SCHEDULE

Roads in Sittingbourne

Crown Quay Lane

The following shall be inserted in the First Schedule (No Waiting At Any Time) in place of the existing entry:

- CROWN QUAY LANE (1) On the eastern side from a point 2 metres north of the southern building line of Grid House to the Junction with Bell Road.
 - (2) On the western side
 - (a) from a point 3 metres south of the southern building line of the Ambulance Station to the Junction with Bell Road:
 - (b) from a point 36 metres north of the Junction with Eurolink Way (B2006) to a point in line with the southern kerbline of Seddingbourne Way;
 - (c) from a point in line with the northern kerbline of Seddingbourne Way, for a distance of 175 metres in a northerly direction.
