**ROAD TRAFFIC REGULATION ORDER ACT 1984**

The KENT COUNTY COUNCIL, acting as the Local Authority and in exercise of its powers under Sections 1, 2, 32, 35, 36, 45, 46, 47, 49, 53, 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, the Traffic Management Act 2004, and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby proposes to make the following order:-

1. This Order shall come into operation on     day of                             2026 and may be cited as “The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Consolidation) (Amendment No.26) Order 2025” (“this Order”)
2. The Interpretation Act 1978 shall apply to this Order as it applies for the interpretation of an Act of Parliament.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, “The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2024” (“the Order of 2024”) shall have effect as though:

The Kent County Council as traffic authority intends to make the Order referred to above as shown on the drawing accompanying this document for the following reasons :-

- For avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising
- For facilitating the passage on the road or any other road of any class of traffic (including pedestrians).
- For preserving or improving the amenities of the area through which the road runs.

NOTICE is hereby given that the Kent County Council proposes to make an Order under Sections 1, 2, 32, 35, 36, 45, 46, 47, 49, 53, 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, the Traffic Management Act 2004, and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act.

The effect of the Order is as follows:-

It is proposed to install a new, or formalise the existing, disabled persons' parking bay outside 52 Berridge Road, 156 Invicta Road, 80 Alma Road, 30 Meyrick Road and 113 Granville Road in Sheerness, outside 51 Cowper Road, 26 Dean Road and 54 Tonge Road in Sittinthegbourne, outside 15 The Willows, Newington, outside 7 St Johns Road in Faversham, and outside 74 Horselees Road, Boughton-under-Blean;

It is proposed to extend the existing disabled persons' parking bay outside 135 Shortlands Road, Sittingbourne across the frontage of 133 Shortlands Road to accommodate two vehicles, and to extend the existing disabled persons' parking bay outside Spicer Homes, Bell Road, Sittingbourne to accommodate two vehicles, as marked on site;

It is proposed to remove the redundant disabled persons' parking bay outside 24 Granville Road and 10 Acorn Street in Sheerness, outside 72 High Street and 13 Gordon Avenue, Queenborough, outside 35/37 Imperial Drive, Warden Bay, and outside 13 Gibson Street, 45 Prince Charles Avenue and 47 Prince Charles Avenue in Sittingbourne.

In Ufton Lane, Sittingbourne, it is proposed to remove the existing residents' parking bay outside 121 Ufton Lane and replace this with double yellow lines to accommodate a new driveway entrance.

The Order includes some changes of an administrative matter which will make no alterations to existing parking and waiting restrictions and will require no changes to existing parking lines or signs.




Outside 156 Invicta Road, Sheerness – Proposed New/Formalising of Existing Disabled Persons' Parking Bay














