ROAD TRAFFIC REGULATION ORDER ACT 1984

The KENT COUNTY COUNCIL, acting as the Local Authority and in exercise of its powers under Sections 1, 2, 32, 35, 36, 45, 46, 47, 49, 53, 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, the Traffic Management Act 2004, and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby proposes to make the following order:-

- 1. This Order shall come into operation on day of 2025 and may be cited as "The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Consolidation) (Amendment No.20) Order 2025" ("this Order")
- 2. The Interpretation Act 1978 shall apply to this Order as it applies for the interpretation of an Act of Parliament.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, "The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2024" ("the Order of 2024") shall have effect as though:
 - (a) Schedule 2 to the Order of 2024 is amended by the replacement or issue of the following Map Tile:

NOTICE is hereby given that the Kent County Council proposes to make an Order under Sections 1, 2, 32, 35, 36, 45, 46, 47, 49, 53, 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, the Traffic Management Act 2004, and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act.

The effect of the Order is as follows:-

In Park Road, Faversham, it is proposed to introduce a short section of double yellow lines on the south side of the entrance to the Recreation Ground Car Park;

In Key Street, Sittingbourne, it is proposed to introduce a 5 tonne waiting limit at all times in the layby on the north side of the road between Key Street Roundabout and 13 Key Street;

In Blenheim Road, Sittingbourne, it is proposed to install a new, or formalise the existing, disabled persons' parking bay outside No.10.

The Order includes some changes of an administrative matter which will make no alterations to existing parking and waiting restrictions and will require no changes to existing parking lines or signs.

A full statement of the Council's reasons for making the proposed Order, a plan indicating the location and the effect and a copy of any other Orders which will be amended by the proposed Order may be examined at Swale House, East Street, Sittingbourne, Kent ME10 3HT by appointment booked by e-mailing engineers@swale.gov.uk or viewed online from 25 July 2025 at www.swale.gov.uk


